Terms & Conditions:

- 5. All the treatments should be performed as per the schedules approved by the Plant Protection Adviser.
- 6. The certified facility should abide by the instructions and guidelines issued by the Plant Protection Adviser from time to time.
- 7. The certified facility shall comply with the requirements and conditions stipulated in the Compliance Agreement. For renewal of validity for continuation the applicant must apply 30 days in advance; failing which annual audit fee will be applicable as fee for registration.
